TERMS OF USE POLICY:

INTRODUCTION:

This *Terms of Use Policy* is applicable to [a] those who use our Service, “Users” (*i.e., visitors to our websites*); and [b] those who advertise on our Service, “Advertisers”. Use of all BarrierFreeChoices services is subject to our terms of use as described in this Terms of Use Policy, and shall constitute a legally binding agreement between you and Barrier Free Choices, Inc. By using any of our services you thereby acknowledge that you have read, understood, and agree to be bound by our terms of use, defined and governed by this Terms of Use Policy.

1. PURPOSE:

Barrier Free Choices, Inc. provides an INFORMATION SERVICE, intended primarily for online usage by, or for the benefit of, people with disabilities residing in, or visiting, the United States of America, and their families, friends, associates and caregivers. Those who are not “disabled” are also welcome to use our Service if useful to them. Primarily, our Service helps those with disabilities to locate resources that are “barrier-free” or “accessible” to them. We also provide helpful consumer information and access to other resources, for people with disabilities and also for the general public.

2. USER AVAILABILITY AND PRIVACY:

The Service we provide is made available FREELY and ANONYMOUSLY to those who may use our Service for personal purposes (our “Users”):

- a. There are NO “Membership Fees” or “User Fees” of any kind;
- b. There are NO “Registration” requirements; and
- c. Our websites DO NOT collect personal information of any kind.

From time to time, we do collect anonymous data about operating systems, web browsers, and pages used by those who visit our websites. Such data is used statistically for periodic updates to our Service to maximize its usability for the majority of our Users, and personally identifiable information is NOT collected in this process.

Advertisers that provide [a] delivery of products and/or services sold; OR [b] any sort of “in-home” services to their customers; OR [c] any products and/or services for sale by phone, mail or via the internet; are exempted from our requirement to maintain barrier-free premises, *if* their prospective customers do not need to actually visit their place of business in the normal course of doing business with them.

4. ACCURACY OF ADVERTISERS’ INFORMATION:

We make every effort to verify the accuracy of all information provided by our Advertisers and/or gathered by our Staff. Users of our Service and Advertisers on our Service hereby agree to indemnify and save harmless Barrier Free Choices, Inc. and its employees, agents, heirs, successors and permitted assigns from any and all claims, damages, or liabilities that may arise from their use of our Service, or from any inaccuracies that might appear on our site, whether such inaccuracies were caused by our Staff, our Advertisers, or otherwise.

Since our Service was first launched, our “downtimes” have been extremely rare and very brief, and our “uptime” is nearly 100%. However, the technological aspect of the service we provide is quite sophisticated, and some aspects of our service do involve reliance on the services of outside vendors, subcontractors, and public utilities over which we have no control.
